# 2015 <br> SUMMARY ANNUAL REPORT FOR THE KROGER CO. 401(K) RETIREMENT SAVINGS ACCOUNT PLAN 

This is a summary of the annual report for The Kroger Co. 401(k) Retirement Savings Account Plan for the year ending December 31, 2015. The Employer Identification Number for the Plan is 31-0345740. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## Basic Financial Statement

Benefits under the plan are provided through the plan's trust fund. The value of plan assets was $\$ 3,635,557,000$ as of December 31, 2015, compared to $\$ 3,391,337,000$ as of January 1, 2015. During the plan year, the plan experienced an increase in net assets of $\$ 244,220,000$ which is the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year. The increase in net assets included plan income of $\$ 459,511,000$ and plan expenses of $\$ 215,291,000$.

- The plan income of $\$ 459,511,000$ includes the employee contributions of $\$ 223,492,000$, employer contributions of $\$ 167,316,000$, net investment gain from the master trust investment of $\$ 66,253,000$ and interest of $\$ 2,450,000$.
- Plan expenses were $\$ 215,291,000$. These expenses included $\$ 2,177,000$ in administrative expenses and $\$ 213,114,000$ in benefits paid to participants and beneficiaries.

A total of 83,482 persons were participants in or beneficiaries of the plan at the end of the plan year.
