To log on

To get started with Benefits OnLine at **www.benefits.ml.com**, you will need to create a User ID and Password. Just click **Create your User ID now** and follow the prompts.

What you need

- U.S. participants need their Social Security number. Non-U.S. participants need the 9-digit internal verification number provided by Merrill Lynch (enter this when prompted for your "Account Number").
- You will also need a Personal Identification Number (PIN), which is sent to you in the mail. If you do not have your PIN, select "Forgot Your PIN" when prompted for your PIN.

Opening your brokerage account

After you create your User ID and Password, you will be prompted to open a Limited Individual Investor Account (Limited IIA) for your equity awards – even if you have another Merrill Lynch brokerage account.*

Just select **Continue** on the **Open a Brokerage Account** screen that appears and follow the prompts.

You can also access the **Open a Brokerage Account** screen by clicking the **Open Account Now** link in the Action Center on the **My Accounts** page (shown below).



Using Benefits OnLine

Benefits OnLine offers a wide variety of tools and resources for managing and monitoring your awards. When you log in, you'll land on the **My Accounts** page, your starting point for viewing your awards.



Shows you:

- Your award balance (the total potential market value of your outstanding awards based on the previous trading day's closing price for your company's stock).
- Your brokerage account balance (if account is activated).

Select the name of your award plan or brokerage account to see more detailed information.

2 Stock Plans

Provides access to information and resources for your awards.

3 Message Center

Shows any important messages that require your attention, including time-sensitive **Alerts** about actions you may need to take.

Click to Chat

Online chat is another convenient way to stay connected with your plan. Depending on the information you're looking for, you can connect with a live agent and have your questions answered on the spot.



Action Center

Alerts you to any actions you may need to take (such as opening a brokerage account) or to information that can help you plan for your financial future.

Section 16/Rule 144

Directors, executive officers, associates and other persons subject to Rule 144 or Section 16 of the Securities Exchange Act of 1934 (as amended) have inquiry access only to Benefits OnLine and cannot exercise stock options, sell shares or open a brokerage account online, and will work directly with your plan's Merrill Lynch financial advisor to open the account and conduct any transactions.

Viewing your award information

When you click on the name of your equity plan on the **My Accounts** page, or on the **Stock Plans** tab, you will be taken to the Grant Summary screen. Here you will see a summary of your awards. To view more detailed information about an award, click on the award's Grant Date or View Details in the Actions drop-down at the right.

Page Highlights

1 Summary Bar

Displays the potential value (unrealized) of your awards based on the previous day's closing price for your company's stock.

2 All Grants

Lists information about all your grants. Select an award's grant date for details about that award, including any recent activity, the vesting schedule and, if applicable, settlement method.

3 Actions

Provides quick access to actions such as accepting an award (if required by your plan), modeling an award, exercising stock options or making a tax election for restricted or performance awards.



Detailed information about your stock options or other awards appears under **Stock Plans** > **Grant Information – Grant Detail**. This section displays your award information and award activity. You can choose to view all your grants or only your outstanding grants.
